THE MOBILE SHOWERS PROGRAM WAS INITIALLY INTRODUCED IN 2015. THE PROGRAM AIMS TO PROVIDE WARM SHOWERS, AS WELL AS OTHER MUCH NEEDED SERVICES, SUCH AS OUTREACH CASE WORKERS AND HEALTH SERVICES.

TSC WAS DEEMED AN ESSENTIAL SERVICE AND THEREFORE CONTINUED TO OPERATE DURING COVID.

4c (Code:) (Expenses \$ 38,784. including grants of \$) (Revenue \$) HOMELESS YOUTH LEGAL AND ADVOCACY PROJECT (HYLAP): HYLAP PROVIDES DIRECT REPRESENTATION TO HOMELESS AND AT-RISK YOUTH AGES 14-27 IN THEIR CRIMINAL DEFENSE MATTERS WHILE ALSO GETTING PAIRED UP WITH AN ADVOCATE WHO CONNECTS THEM TO SOCIAL SERVICES TO PROVIDE A MORE HOLISTIC APPROACH TO ADDRESSING BARRIERS IN THEIR PATHWAY TO SUCCESS.
